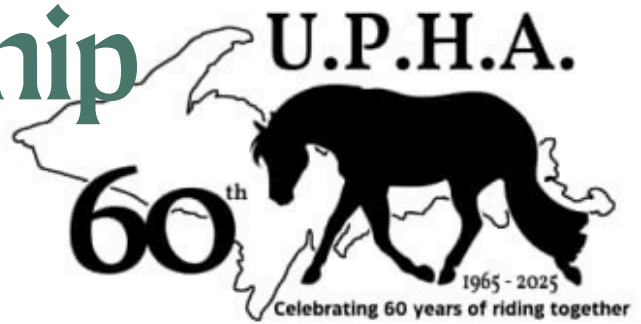

In the event an entry or membership form is not signed or presented, appearance on the grounds or at the event of any UPHA activity as an exhibitor, handler, owner or consigner shall be deemed to be acceptance of the above conditions of this rule.
